

- The purpose is to share Thoughts, Feelings, and Experiences in a safe and confidential space

- Express your opinions
- Listen to others
- Give everyone a chance to speak
- Respect the ground rules
- Respect each other

Ground rules

- Speak openly and honestly
- Listen carefully and respectfully to each person
- Keep comments brief and stay focused on task
- Explore differences respectfully and look for common ground
- Trust that the facilitator has the best interest of the group at heart
- Silence cell phones
- Be respectful of the opinions of others




What is your GENDER?


What is your Ethnicity? MARK ALL THAT APPLY




What is your AGE?




Is law enforcement adequately addressing the concerns of the community?


When comparing treatment of community members by law enforcement, do you believe that people of color are consistently treated less fairly by law enforcement officers than are white people?




If you answered yes, frequently, or sometimes, do you believe that law enforcement officers can change their behavior to consistently treat people of color fairly?






When comparing treatment of community members by law enforcement, do you believe that people with mental health issues/concerns are consistently treated less fairly than are people who do not have these issues/concerns?



If you answered Yes, Frequently, or Sometimes, do you believe that law enforcement officers can change their behavior to consistently treat people with mental health issues/concerns fairly?







Do you think that the process of dialogue is beneficial in addressing important issues in our community?








Is law enforcement adequately addressing the concerns of the community?













When comparing treatment of community members by law enforcement, do you believe that people with mental health issues. concerns are consistently treated less fairly than are people who do not have these issues/concerns?



Comments

- We had a lot of discussion today. Talked about homelessness, drug addiction, emotional problems.
- We have to build relationships and communication with Law Enforcement.
- As a community, we need to do more.
- Love, compassion, awareness, all have to be in the equation.

Comments

- Trent- First and foremost, I have totally low feeling about anybody with a badge, based on my experience growing up. My uncle died in my arms. I still have that anger towards all officers. But when I told the officer what I had experienced, the officer shared with me situations that he had gone through, and now I realize that I could see things from the officer's pov.
- His main priority that he goes home-that his partner goes home safe.
- I had one experience with one idiot officer, and that doesn't have to be everything for me for my life. I had a better conversation with the officer at my table.
- I had a bad experience with a cop from Central, telling him about my brain injury, and he told me to stop crying, and to grow up, and that was inappropriate.
- Today I had a better conversation with the officer at my table.


Comments

Mental illness is not a crime


Comments from LA Police

- Trauma training- train all the agencies, train everybody.
 When you are working with someone who is already traumatized, we don't want to re traumatize them.

- We hear you and we thank you for being honest.





Law Enforcement is distributed among the County of Los Angeles in:


