DAYS OF DIALOGUE IS... FACILITATED DIALOGUE

- Structured Conversation
- The facilitator acts as a moderator,rather than a leader and is always neutral
- The purpose is to share Thoughts, Feelings, and Experiences in a safe and confidential space

DIALOGUE PARTICIPANTS ARE ENCOURAGED TO...

- Express your opinions
- Listen to others
- Give everyone a chance to speak
- Respect the ground rules
- Respect each other

GROUND RULES

- Speak openly and honestly
- Listen carefully and respectfully to each person
- Keep comments brief and stay focused on task
- Explore differences respectfully and look for common ground
- Trust that the facilitator has the best interest of the group at heart
- Silence cell phones
- Be respectful of the opinions of others








What is your Ethnicity? CHECK ALL THAT APPLY






What is your AGE?




Are you in charge of your life?

Is law enforcement adequately addressing the concerns of the community?



When comparing treatment of community members by law enforcement, do you believe that people of color are consistently treated less fairly by law enforcement officers than are white people?






Have your opinions changed as a result of this Dialogue?






Do you think that the process of dialogue is beneficial in addressing important issues in our community?




Is law enforcement adequately addressing the concerns of the community?






If you answered Yes, Frequently or Sometimes, do you believe that law enforcement officers can change their behavior to consistently treat people of color fairly?








What, if any, action(s) do you expect to take as a result of this dialogue? CHECK ALL THAT APPLY

Youth:

- I want to be ...
 - a pediatric nurse
 - a criminal lawyer
 - an RN
 - Catch me in five years when I'm working at Kaiser!
 - I'm gonna graduate from high school, and go to Whittier College.
 - You've got to have goals, and milestones. You've got to have a plan.

Youth:

- I feel that mass incarceration is slavery.
- Most times, people are being falsely convicted because they are people of color.
- Mind you, half the pay-off money goes to the lawyers.
- "Sooner or later you're coming in again." Why do they always say that to us?
- Ya'll gotta give us chances- we're not done growing!

Facilitators:

- Before starting I introduced myself and shook hands as the students trickled into the classroom. One of the students remembered me from a previous session, jumped out of her chair, ran to me with a smile and hugged me as if I were a long-lost auntie or grandma.
- When asked what "bias" meant the students didn't know. "Prejudice" was meaningful to them. We discussed their prejudices and the prejudices of law enforcement. Our officer introduced profiling by drawing attention to their body language and the messages that could be drawn by it.

Officer asked if there was ever a time when a cop had been nice to them? Practically everyone had a story. There were two standouts:

- One young lady shared the time that she wasn't going to school regularly so a cop bought her a bike to encourage her to go.
- Another shared that when she was being taken from her mother she was put in the back seat of a cop car. The officer asked if she had had anything to eat. She hadn't. He bought her a big breakfast. Three months later he visited their home to bring gifts and to see how they were doing.

 All the participants were young males under the age of 18. They were primarily focused on police procedures and how the policies interface with their experiences. Our LAPD representative was a female and this might have given our session a different dynamic. I spoke to two of the participants while we were having lunch, and one of them referred to me as "jefa," a common term in the Mexican community for mother or mother figure. My co-facilitator was also a woman. We were three older women dialoguing with eight young men of color whose faith in police was sparse at best, yet the presence of a Latina officer in her early 30's gave them another face of the LAPD.

- "Why aren't you in my hood, you are nice, you understand us." They became very interested in how they should react when stopped by police, and the officer explained about the act of "detaining" an individual: "You should ask, am I being detained?"
- The 90-minute dialogue was primarily focused on the young people's past and present dealings with the police; they wanted to know to "handle it" when confronted with police policy and cops "doing their job."
