- Structured Conversation
- The facilitator acts as a moderator, rather than a leader and is always neutral
- The purpose is to share Thoughts, Feelings, and Experiences in a safe and confidential space



DIALOGUE PARTICIPANTS ARE ENCOURAGED TO...

- Express your opinions
- Listen to others
- Give everyone a chance to speak
- Respect the ground rules
- Respect each other



GROUND RULES

- Speak openly and honestly
- Listen carefully and respectfully to each person
- Keep comments brief and stay focused on task
- Explore differences respectfully and look for common ground
- Trust that the facilitator has the best interest of the group at heart
- Silence cell phones
- Be respectful of the opinions of others




PRE-DIALOGUE SURVEY RESULTS




GENDER






ETHNICITY













IS LAW ENFORCEMENT ADEQUATELY ADDRESSING THE CONCERNS OF THE COMMUNITY?








HAVE YOUR OPINIONS CHANGED AS A RESULT OF THIS DIALOGUE?











Comments & Dictures



We want to have police officers as a part of our community. We are working together to figure out the issues. There are many opportunities and approaches.

Take care of people out there in the street. Expect police to be compassionate and talk to and take care of homeless people, even though they don't like them.

There are many problems that cause people to be homeless.



Don't limit people who want to help. Lower the barriers for people who want to get involved and give back.



- 1. One person said, "after two weeks of being homeless, mental illness sets in." He explained that after two weeks of not being able to go into a bathroom and close the door when you need to relieve yourself a person begins to experience a mental breakdown. Nowhere to call "home" causes an enormous sense of loss and hopelessness and helplessness.
 - 2. Police and people who work to assist the homeless need to be aware of the difference between Mental Health versus Mental Illness. ... explained that Mental Health concerns can be remedied by programs that provide housing, education, training, financial help & etc. Mental Illness requires medication and treatment programs. All of the above are needed to improve and change things within the homeless community.

3. Someone suggested police on "foot patrol" would allow the community and the police to have closer and more frequent communication. ... thought this might reduce some of the fear between the police and the community. ... also thought that if the fear could be reduced, then there would be room for trust to begin to develop on both sides.

4. It was unanimous within the group that the police needed to be better trained to recognize, understand and respond to people with mental health and mental illness without killing them. The officer agreed and said most officers would also agree with that statement.





Human trafficking: We see prostitution as that person's problem. But what are the underlying issues?

There are opportunities on Skid Row. You CAN live a different way.

I believe that the way to change things around is to change our attitude. Not just the police officers' attitude, but all of us.

Media often puts out inaccurate information. Without accurate information, we maintain our own bias.

Having more dialogues like this, creating more spaces for people to talk. Engaging the media and educating them about what we know and what we hear.

There is a wide spectrum of mental illness. People have issues. But many can be resolved with access to resources.

There is the Mental Health Unit that works with LAPD.

That unit need to have more of a presence.

Everyone needs more training.





Let's come together in a positive way to stop negative things. People are afraid of police because of... thousands of reasons.

People with mental illness shouldn't have guns.

Police officers could change. People working on street could help. Provide professional mental help. Outreach to individuals in hospitals. Provide housing.

Police are here to help us. Try not to be afraid of them. We have to reach out to our peace officers and ask for more of these dialogues.

We need to be creating the space to have more dialogues. The place and the space.





Things to Help Community

- A. Give donations to Missions not the streets
- B. More funding for shelters, churches, missions
- C. Educate communities about homelessness
- D. Have empathy for homeless people
- E. Give information to the homeless community about the care that is available.





I have an added appreciation for the officer who took off his weapon. And he talked to us not from the standpoint of an officer, but as someone who gets what we are trying to do, and as someone who has his own story to tell.













People give up too quickly.

Need people to walk besides them throughout the length of the program

Need people who truly give their heart, not those who are doing it for their resume or to look good in a campaign.

Lower the barriers so that people who want to help, can help.

What is already out there that is not working:

Not enough shelters, housing production Provide mental health services

Need to provide life skills & benefits that are needed
Mental & emotional help
Provide the tools & assistance
